Reports. Police Commissioner Report. Report was available for review. Crew Report. Chris Kirmer read the report: re-wired transformers with coated wire, put bird guards on transformers in trouble spots, replaced street lights, annual dielectric tests were done, repaired leak on 9th Street, radium water sample test on South and East Wells, Simon's from Limon completed annual flush of sewer lines, completed water tap for new house at 830 W. Colorado Street, made room for Caterpillar skid steer at landfill building, trial tested Caterpillar skid steer for a week, put up Christmas decorations. Administrator Report. Administrator Tanner updated the board on tasks in November: worked on the budget, worked on ordinance for water and sewer rates, test drove a 2009 Dodge 5500 flatbed truck in Ramona, Oklahoma, auction price rose higher than willing to spend for its' mileage, drove to Lindale, Texas to pickup the correct transfer case for 2012 Dodge bucket truck, the truck is at Jr's Garage in Granada due to an oil pressure issue, Junior determined the truck had injector issues and has A thrown rod, Dodge approved Jr's Garage for the repair and will replace the engine as it was under warranty, some labor, fluids and filters will be at the Town's expense, Caterpillar skid steer was provided for demo, purchased a Wacker RD11A double drum roller. Clerk/Treasurer's Report. October's financials were presented. The library fund company was transferred through general fund company for 2021. The 2022 budget represents the same by adding library line items to the general fund and the library fund page will phase out. Library Report. October's count of patron visits and checked out material was available. Planning Commission Report - No New Business. Trustee Rushton motioned to approve all reports as given. Administrator Tanner will see if rate will be reduced for less mileage, however it could then result in a charge from the Transfer Station. **East Lot Bid Review.** Four packets were released, only 1 returned and presented in the board packet for review. The bid was for purchase of parcels #1 & #2 in the amount of \$35,000.00. Trustee Davis motioned to accept the \$35,000 bid for the sale of parcels #1 & #2. Seconded by Trustee Brian. Motion carried 4-2. Trustees Holdren and Rushton opposed.
