Reports. Police Report. Chief Dougherty presented to the Board his January police report and the completed December report. He commented on there being 27 service calls in Holly for January. Chief Dougherty gave a brief statement on the number of hours each person had put in for January and monetary values for the month. He stated they had interviewed two people for the police clerk position and would be continuing this process. Administrator Report. Administrator Holland began by discussing the snow removal for January. On January 10th he had a ZOOM meeting with McGuire on the water tank inspection; there is nothing new for repairs. He continued with discussions on all the water main breaks that transpired in January, from 3rd street near the telephone company to two near the water tank and the one on 7th street. We met with RESPEC Engineering from DOLA on January 19th to look at our water project. He reminded the Board about the Colorado Rural Water Conference on March 18th-20th which he and Tysh will attend. We met with Vision Metering Systems to discuss water and electric metering options. The Town has been working with Holly School to replace lights in the north parking lot. Trustee Melcher interjected information on the airport usage and that there is one hanger available if anyone needs it. Argie Thrall is currently paying for the use of the space. Clerk/Treasurer's Report. December Financials were presented along with viewing all current account balances, no questions were asked. The Clerk/Treasurer presented the police/court and budgeting status reports for January. The Clerk updated the Board with the status of the USDA financial requests. Currently they are waiting for the federal government to pass the budget; then they will proceed. I contacted Nick at Element Engineering requesting him to look into financial offers available through the Department of Local Affairs and Colorado Department of Public Health and Environment. Election status reported with one mayoral nominee petition and two trustee petitions returned. Colorado Department of Revenue has approved our Ordinance as of January 31st to put referendum 2A on the ballot for a one percent sales tax increase. Discussed old ordinances and their terms needing some updating and the decision was to follow the Court Judge's direction. There was a discussion on the Town of Holly being debruced. Flint Timmins from Department of Local Affairs provided and updated on the

Holly Community Complex new scope status. **Library Report.** There were 96 patrons, with 70 checkouts and 4 computer usages. Trustee Swisher motioned to approve the reports as given. Seconded by Trustee Ice. Motion carried 5-0.
