Reports. Administrator Report. Administrator Holland reported: February 2<sup>nd</sup> repaired a water main break at Park and Highland, it was a failed fitting, February 4th met with Doug Schwenke, JD Hydro Engineer to discuss plans to switch wells to liquid chlorine, February 8th Larry Sitts, Blaine Ice, and Randy Holland attended the Granada town board meeting and discussed police grants and contracting with them to receive patrol service, we have switched the lab for water testing to Colorado Analytical, February 10th Granada PD looked over our police vehicles to see what it will take to re-equip them and have them ready for service, we have been doing snow removal as needed, February 21st Board Workshop regarding Fire Dept/Shop resulted in directing staff to look for potential bidders for new building, February 23rd Blaine Ice and Randy Holland attended the ARPA board meeting in La Junta, Schafer Auto bailed and hauled off the metal pile, approximately five semi loads, Tysh Yarborough and Randy Holland attended another online class on water treatment and distribution systems, rooms are reserved and classes scheduled for CRWA conference in April, JR's Convenience Store has stopped charge accounts. Larry Crum, Tysha Yarborourgh, and himself have Conoco cards, electrical safety gloves have been sent out for testing and returned, next cycle has not been set, Commercial Club is making property list applicable with the Brownsfield regional grant program. Trustee Swisher provided more information on the program and upcoming meetings. Clerk/Treasurer's Report. January's financials were presented. Library Report. Invitation for Bids – Pad and Shell; New Build Fire Dept/Shop. Bid packet specifications were presented. Discussion resulted in adding an additional bid request for new build, pad and shell at the East Lot. The bid package will be updated to include request for bid amounts on two options: different sizes and different locations of a new building pad and shell. Lifeguard Wage Scale. Trustee Swisher motioned to approve the Lifeguard Wage Scale for 2023. Seconded by Trustee Brian. Motion carried 6-0. Opioid Settlement (II) Participation. Trustee Ice motioned to approve participation in the Opioid Settlement (II). Seconded by Trustee Swisher. Motion carried 6-0. Town Property: Old Golf Course Use. Holly Pride Committee would like to use the old golf course for Demolition Derbies, etc. The Board directed the Town Administrator to create a property use agreement; granting Pride Committee permission to use the property as they deem fit for benefit to the community. Event liability was expressed.
