

**ORDINANCE NO. 446**

**AN ORDINANCE TO ADOPT A BUDGET**

**AN ORDINANCE SUMMARIZING EXPENDITURES AND REVENUES FOR EACH FUND AND ADOPTING A BUDGET FOR THE TOWN OF HOLLY, PROWERS COUNTY, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE FIRST DAY OF JANUARY, 2008, AND ENDING ON THE LAST DAY OF DECEMBER, 2008.**

WHEREAS, the Town of Holly has appointed Marsha Willhite, Town Administrator, to prepare and submit a proposed budget to said governing body at the proper time; and

WHEREAS, Marsha Willhite, Town Administrator has submitted a proposed budget to this governing body on November 7, 2007, for its consideration, and;

WHEREAS, upon due and proper notice, published or posted in accordance with the law, said proposed budget was open for inspection by the public at the Town Hall. A public hearing was held on November 7, 2007, and interested taxpayers were given the opportunity to file or register any objections to said proposed budget, and;

WHEREAS, whatever increases may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance, as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN OF HOLLY, PROWERS COUNTY, COLORADO:
