

RESOLUTION 2007-10

A RESOLUTION BY THE BOARD OF TRUSTEES OF THE TOWN OF HOLLY AUTHORIZING RATE ADJUSTMENTS TO ALL CLASSIFICATIONS OF THE LANDFILL AND GARBAGE DEPARTMENT

WHEREAS, the Town of Holly constructed and maintains a landfill which must comply with Federal Sub Title D regulations requiring a facility waiver, monitoring, and closure and post-closure; and

WHEREAS, the Town of Holly employs a landfill attendant to maintain the landfill and monitor proper use of the landfill; and

WHEREAS, the Town leased a wheel loader for the operations of the landfill; and

WHEREAS, the Town has not increased landfill or garbage rates since 2004; and

WHEREAS, the Town has not increased dumpster rates since 2001; and

WHEREAS, the department's rates do not allow sufficient reserves for future capital needs or expenditures.

NOW, THEREFORE BE IT RESOLVED by the Board of Trustees of the Town of Holly, Colorado, a municipal corporation, that the following garbage and landfill rates are hereby adopted and will become effective for the first billing period commencing after December 31, 2007:

1. RESIDENTIAL RATES PER MONTH:

	<u>GARBAGE PICKUP RATE</u>	<u>LANDFILL USE RATE</u>
a) vacant houses, apartments and businesses	\$ 2.15	\$ 0
b) single person residences and apartments	\$ 8.50	\$ 3.50
c) family residences and apartments	\$ 15.00	\$ 7.50
d) out of town residences and apartments	\$ 19.50	\$ 7.50
e) special pickups*	\$ 21.50	\$ 0

* Special pickups include items that are not in the normal location for the residence, either the alley or the street, or pickups that require the garbage truck or personnel to leave their normal route. Also included, are all items which would not qualify to be picked up by the trash compactor truck. Examples of special pickup items: refrigerators, burn barrels, furniture, large branches, and any other item which could not be hauled by the resident and would require Town equipment and labor.

This rate is for one half hour.

2. DUMPSTER RATES PER MONTH:

a) per load for non-customers (household garbage, pickup load or less)		\$ 17.00

c) to use landfill on non-open days (any customer)		\$ 17.00
d) commercial hauls* per truck load (any customer)		\$ 43.00
e) hauls from other municipalities or contractors in the business of disposing of solid waste		
	per compactor	\$430.00
	per regular truck	\$129.00

* Commercial hauls are considered to be anything hauled to the landfill by/for a customer or non-customer for any of the following: extensive house or business demolition, remodeling, renovation, roofing, lumber, or any other material which would fall into this category.

The commercial haul rate is not intended for normal yard clean-up and tree care for customers.
