**Minutes, December 7, 2011 Regular Board Meeting and December 28, 2011 Special Board Meeting.** David Crossland motioned to approve the minutes of the December 7, 2011 Regular Board Meeting minutes and the December 28, 2011 Special Board Meeting minutes, seconded by Brad Simon. Motion carried 4-0.

**Reports.** **Police Commissioner Report.** Report available for Board review. **Crew Report.** Fence and gate for sewer lagoons and shooting range were repaired upon completion of the new Highway 89 Bridge. Crew located water main along Highway 50 prior to Altus Environmental construction which included boring under highway. Work on guy wire and anchors for utility poles was done. 500 hour service was done on Caterpillar Loader. Trees trimmed out of service lines on 10<sup>th</sup> and 11<sup>th</sup> Street. Crew worked around the clock keeping emergency snow routes open following the December 19<sup>th</sup> snow storm. Hydraulic cylinder leak repaired with new seal kit on aerial truck. **Administrators Report.** Administrator is pursuing January scheduling for a Zoning Open House to be hosted by DOLA representatives. Tentative location of meeting will be in the Holly Post Office foyer. Colorado Sales and Use tax rates reviewed with Board. Trustee Vazquez present at 7:25 pm. Administrator has new school project punch list which details the demolition projects the Town will be assisting with. Trustee Jones present at 7:27 pm. Tennis court and baseball field work began at the school this week. Demolition work and utility abatement work will continue at every available opportunity until completion. PTO policy discussed with review of vacation and sick pay hours detailed for 2011. **Clerk/Treasurer Report.** 2012 Municipal Election calendar posted at Holly Post Office. Three trustee positions and the Mayor position will be on the ballot for the April 3, 2012 election.
