Reports. Police Commissioner Report. Report was available for review. Crew Report. Power outage came from a phase down in Hartman, used ARPA Generator for 2.5 hours. Second outage was a frozen tree branch at Holly Housing fell on power line, third outage caused by owl. ARPA Generator used for two hours due to truck hitting pole in Lamar. Filled ARPA Generator with fuel. Began intake on the forth layer of the landfill cell. Looking into adding a fenced area with lean-to on landfill building for e-waste. Took bucket truck to Hartman's water tower for use in water tower inspection, billing for use and employee time will apply. Shut off water service for residents with frozen and broken pipes. Clerk/Treasurer's Report. January's financials were reviewed with the Board. Library Report. Trustee Holdren motioned to approve the lowest bid, Burtis Motors of Garden City, Kansas in the amount of \$28,624. Trustee Stephens seconded. Motion carried 4-0. "Pedal the Plains"- Update. The Commercial Club, Churches, and organizations are working together to organize the needs for the event. USDA Search Grant. USDA approved funding \$30,000 to the Town of Holly for a Preliminary Engineering Report and Environmental Report in regards to the solid waste disposal needs by identifying the scope to construct a Solid Waste Transfer Station. Trustee Holdren motioned to accept the USDA Search Grant upon the Attorney's review of the contract. Trustee Moldenhauer seconded. Motion carried 4-0.

New Business. Airport Liability Insurance Coverage - \$1,992 Annual with Brase Insurance (\$1,811 last year). Trustee Holdren motioned to accept 2019 coverage for \$1,922 with Brase Insurance. Trustee Stephens seconded. Motion carried 4-0. Swimming Pool - Wage Scale. Trustee Holdren motioned to approve the provided wage scale, seconded by Trustee Stephens. Motion carried 4-0.

<u>Miscellaneous.</u> Selection Survey. Town Administrator skill surveys for Steve Rabe appropriate for administrator hiring process. Commercial Club- Financials of Theater Operations. The Holly Pride Committee's 2018 financials were provided for review in the board packet. The board request for continuation of an annual financial report from the Holly Pride Committee.
