<u>Approval of Current Bills.</u> Trustee Swisher motioned to approve current bills subject to review of the Finance Committee on October 13, 2021 at 8:30 a.m. Seconded by Trustee Brian. Motion carried 6-0. **Notices and Communications.** None.

Reports. Police Commissioner Report. Report was available for review. Crew Report. Michael Tanner read the report: added transformer at 8th and 9th Street alley, replaced power pole and guy wire at Claude Cathcart, replaced transformer at Bagley, cut out replaced at Jerry Smith Transformer, mast/wiring/lights replaced at arena for Fair, Friday and Saturday free dump day event, cement sprinkler valve box poured at South Park and custom lids made for it, two sprinkler valves replaced at South Park, plans made for new sandbox around the swings at South Park to meet CIRSA compliance, North Park and Pool bathrooms winterized, swept streets, 3-inch water meter replaced at Nursing Home, several water meter pit lids raised, Fair set-up/clean-up/teardown/barricades/tables moved/banners, etc., repairs on vehicles and equipment:#13-water pump, radiator, pulley; brush hog-gear box shot; sweeper-new brushes; little John Deere mower-new belt and alternator, added a cement slope to complex door. Administrator Report. The shooting contest has been cancelled. The next 2022 budget workshop scheduled for October 21, 2021 at 6:00 p.m. The "Open for Business" grant submitted for Holly Inn Suites was not awarded any funding. The bid packet for the East lot will be ready by the November 3, 2021 meeting. We are waiting for a revised letter from the Town Attorney and will postpone action on Vaquero Ventures new proposal. Working on bid packet for Highway 50 sewer manhole repair. Question from last meeting regarding expanding voting and board eligibility to residents outside town limits was referenced by email responses from Colorado Municipal League (CML) Karen Goldman specializing in elections and the town attorney's confirmation that Holly must follow Colorado Revised Statues regarding eligible voters or become home rule. Clerk/Treasurer's Report. August's financials were presented. Administrator Tanner included a detailed - eight month status of the following departments: Sheriff, Library, Theater, Parks, Streets, Swimming Pool, RV Park and Airport. **Library Report.** August's count of patron visits and checked out material was available. The PC and Chromebook have come in and are set up for use, reading to the classes at the school will resume. **Planning Commission Report – No New Business.** Trustee Davis motioned to approve all reports as given. Trustee Holdren motioned to approve and adopt Ordinance No. 541. Seconded by Trustee Brian. Motion carried 6-0.

New Business. Colorado Intergovernmental Risk Sharing Agency (CIRSA) 2022 Quotes. Property Casualty \$32,973.92 (2021 - \$30,297.24) Workers Compensation \$9,509.00 (2021 - 11,159.00). Trustee Holdren motioned to accept the CIRSA Property Casualty and Workers' Compensation quotes for 2022 as presented. Seconded by Trustee Rushton. Motion carried 6-0.
